## TERMS and CONDITIONS:

1. Vendors and Exhibitors must check-in at the Show Command Post prior to move-in.
2. Every vendor will receive 2 badges free with up to 5 tables; 3 free with up to 9 tables, 4 free with 10 or more tables (additional badges @ \$5.00 each) in the information packet available at the time of move-in.
3. Electricity is available at \$20.00 per 110-volt drop. Electricity must be ordered in advance as on-site electrician rates may apply if electricity is ordered at the show. **Vendor must supply its own commercial grade extension cord which is less than 25 feet.**
4. Security from move-in, Friday through the close of the show on Sunday will be provided. However, The Piedmont Division Model Train Show sponsored by the Piedmont Division, NMRA and the Clarence Brown Center are not responsible for any loss or damage to vendor or exhibitor property. We suggest you cover your exhibit and take whatever other precautions you believe necessary to protect your property.
5. Tables are sold for the two days of the show only.
6. Train-related merchandise must be your main focus of all merchandise displayed.
7. Exhibit space location is solely at the discretion of The Piedmont Division Model Train Show sponsored by the Piedmont Division-NMRA. Please attach any special requests for your exhibit space with this application, but The Piedmont Division Model Train Show sponsored by the Piedmont Division-NMRA cannot guarantee adherence to the request.
9. Vendors/Exhibitors must stay fully set-up and open until 4:00 PM Sunday. Any vendor/exhibitor who does not stay fully set-up will risk denial for space at future shows.
10. **Vendors/Exhibitors must check-in by 9:00AM, Saturday or forfeit the tables without refund.**
11. Tables are considered sold when The Piedmont Division Model Train Show confirms your paid application, and is non-refundable.
12. Vendors/Exhibitors must not tack decorations or coverings to ceilings, walls or floors.
13. Vendors/Exhibitors must collect sales tax and remit to Georgia Dep't. of Revenue. Forms will be distributed at the show.
14. Vendors/Exhibitors must comply with the policy regarding driving-in of vehicles into Clarence Brown Center.
15. Vendors/Exhibitors must not assign/sublet all or parts of allocated space without the consent of show management.
